Copyright page, ISBNs and Barcodes

Prelim pages, which are covered in another Guide, include a Copyright page which, although not mandatory if you only intend to distribute your book privately, allows you to declare copyright ownership and provide some necessary details about your book which aid library cataloguing.

If you intend to sell your book publicly you will need an ISBN (International Standardized Book Number)* and include it not only on the Copyright page but also on the back cover where it will appear together with a Barcode. In the UK the Copyright page of all publicly distributed publications should also include the following details:

All rights reserved. This book or any portion thereof may not be reproduced or used in any manner whatsoever without the express written permission of the publisher except for the use of brief quotations in a book review or academic journal.

OR

All rights reserved. No part of this book may be reproduced in any form, by photocopying or by any electronic or mechanical means, including information storage or retrieval systems, without permission in writing from the author or the publisher of this book.

You may wish to also include credits for design, production, editing and illustration on the copyright page.

Should you wish to sell your book in the USA you should also include their Library of Congress cataloging-in-publication reference.

If your book is a paperback edition and you later decide to publish in hardback (or vice versa) you will need a new ISBN and barcode to identify that new edition. You will also need a new ISBN if you republish the book under a new title.

Note: By UK law all publications which are sold publicly must provide one free copy to the British Library Legal Deposit Office. In addition you can also provide one free copy of your publication to each of the Bodleian Libraries of the University of Oxford, Cambridge University Library, The National Library of Scotland, The Library of Trinity College, Dublin and The National Library of Wales – although this isn't a legal requirement unless any, or all, of these libraries specifically request a copy of your publication.

Some eBooks and Audiobooks also require separate ISBNs.

1: ISBNs specifically refer to books while ISSN refer to periodicals. ISSN are provided free of charge by UK Serial Publications. If you are planning to publish a periodical you will find all the necessary help online at http://forms.bl.uk/bibliographic/index.aspx?_ga=2.75739541.1495344548.1581517914-62237836.1581077546

2: ISMNs specifically refer to music publications. In the UK ISMNs may be purchased online from the website of Music Publishers Association at <https://mpaonline.org.uk/resources/uk-ismn-agency/> – music publishers outside the UK should visit: <https://www.ismn-international.org/agency>

* When submitting your publications details you may provide your own ISBN. Alternatively, on request, **THEPUBLISHING.CO.UK** will supply an ISBN for your title from our stock, however the way that ISBNs are assigned by the UK issuing authority means that **THEPUBLISHING.CO.UK** would be nominated as the publisher of your book. So, if you wish to

be identified as the publisher you would need to purchase your own ISBN. The issuing authority in the UK is Nielsen UK ISBN Agency (<https://www.nielsenisbnstore.com/>).

You can set up additional imprints under your publisher name but you will still be the owner of the ISBNs and therefore the registered publisher.
